Fictional document — demonstration example

This document is produced by the Blue Lemon Agent website to illustrate what an AI agent hands to its users. The companies, matters, amounts and people in it are invented. It has no legal, accounting or commercial value.

Fictional document, produced for the demonstration. **Both outcomes are drafted, not only the one that acts.** Closing a signal commits as much as keeping it open: if the payment goes out and the account was fraudulent, it is the reasoning for the closure that will be read again.

Reasoning	The four departing traits, each with its source
Measure	Suspension until confirmation by call-back; later instalments put on hold
Signatories	Finance director (decision) and treasurer (execution)
Supplier notification	Letter attached: notice of the postponement, reason stated without imputation, request for confirmation through the usual channel

Section	Content prepared
Next step foreseen	Referral to the audit committee if the call-back does not disprove it

Version B — payment maintained and signal closed

Section	Content prepared
Subject	Closure of the signal, payment maintained on the due date
Reasoning	Change of bank announced in January, confirmation obtained, document added to the file
Condition written in	The closure holds only if a confirmation obtained outside email is on the file
Signatory	Finance director
Traceability	The reason for closure is kept and will make the decision readable again at fourteen months

What the preparation changes in the calendar

Step	Without a built file	With a built file
Gathering the documents	Several days, between two closes	40 minutes, with no human intervention
Decision	After the gathering — day 11 in the previous case	6 minutes of reading
Notification to the supplier	To be drafted	Written, sent the same day

The agent signs neither version. It writes both so that the decision is a choice of a few minutes between two reasoned texts, and not several days' work at the end of

which the money has already gone.
