Clause	Content
Purpose	Read the logs of the listed sources, and nothing else — no access to business content, no writing
Scope	Sources named individually, added one at a time and never by family
Term	Three weeks for the pilots, renewed in one word on the figures
Withdrawal	In one word — collection stops, the archives remain with the company
Trail	Every source activated is logged with the signature that covered it
