The reserve is not meant to replace the period's news. **It is released whenever a period has fewer than six candidates** — precisely the months in which, historically, Alveor's issue did not go out. **Two issues' worth is available today.**

No content is created to pad an issue. The agent composes from what exists and what the company has published or approved. Producing the content itself is the job of

a dedicated writing agent, upstream.
