## Fictional document — demonstration example

This document is produced by the Blue Lemon Agent website to illustrate what an AI agent hands to its users. The companies, matters, amounts and people in it are invented. It has no legal, accounting or commercial value.

**Fictional document**, produced for the demonstration. **Only three acts run without being asked, they are named, and each is withdrawn in one word.** Everything that commits the company to a new period goes through a signature — handed over in minutes, with the complete file behind it.

## The automatic correction that works both ways

**If an amendment changes a deadline, it is corrected and flagged**, with the old and the new date side by side, and the amendment clause that changes it. **A deadline never moves in silence**: the move is written to the log, with the document that grounds it.

## What goes through a signature, and how fast the file arrives

## What the log keeps
