Deadlines without an identified clause on the first pass: 26 out of 1,840.

Measured cause: 26 paper contracts from 2017-2018 scanned at 150 dots per inch, text never recognised. **Treatment: 19 recovered by cross-referencing later amendments in two days, 7 by letter requesting a signed counterpart, returned within three weeks. Portfolio complete: 412 out of 412.**

What the legal department approves: the inventory by family — clients, subcontractors, leases, insurance. **Approval switches the quarterly spreadsheet to continuous tracking; current paths and file names keep working, nothing is renamed or moved.**
