Fictional document — demonstration example

This document is produced by the Blue Lemon Agent website to illustrate what an AI agent hands to its users. The companies, matters, amounts and people in it are invented. It has no legal, accounting or commercial value.

Fictional document, produced for the demonstration. **A mandate is a written authorisation bounded in advance**: which acts, up to what amount, for how long, on what conditions, and how it is withdrawn. **It turns a decision that has to be retaken every time into an act executed in minutes.**

The five bounds of the proposed mandate

Bound	Content	Why it is there
Purpose	Filing termination and renegotiation letters, supplier contracts only, within the notice window	The mandate covers a precise act, not a vague category
Cap	€150,000 of annual value per contract · €600,000 cumulated over 12 months	The maximum committed is known in advance

Bound	Content	Why it is there
Term	12 months, reviewed at month 6	A mandate with no date renews itself by oversight
Condition of execution	Letter model signed by you · 48-hour notice of intent before every filing	One word during those 48 hours stops the letter
Withdrawal	Immediate, on a single message, no reason to give	Reversibility is what makes the mandate signable

What stays with the legal department's signature

Act	Treatment	Time for the file to be ready
Client contracts, whatever the amount	Head of legal signs	Complete, priced and reasoned file in under 10 minutes
Supplier contracts above €150,000	Signature	Under 10 minutes
Renewal committing a new multi-year period	Signature	Under 10 minutes
Supplier contracts under €150,000, within notice	Mandate	Filed in 8 minutes

What the mandate returns, measured on the last twelve months

Finding over 12 months	Value	With the mandate
Notice windows closed with no letter filed	7	0 — the letter goes within 8 minutes of the window opening
Terms carried over for want of a filing	€61,000	Recovered

Finding over 12 months	Value	With the mandate
Average time from decision to filing	6 days	8 minutes
Traceability	Letters filed by hand	Filing receipt and timestamped log, exportable

Review at month six: number of letters filed, amounts concerned, gains obtained, stops requested during the 48-hour notice. **The mandate widens or tightens on those figures, and withdrawal stays immediate at any time.**
