Fictional document — demonstration example

This document is produced by the Blue Lemon Agent website to illustrate what an AI agent hands to its users. The companies, matters, amounts and people in it are invented. It has no legal, accounting or commercial value.

Fictional document, produced for the demonstration. **Of 2,840 files built, 176 had to be reworked by a handler because the matching of cover was incomplete — 6.2 %**. The figure is published by the agent, with its cause and the correction already under way.

The cause, and it is precise

The comparison that settles it

It is not the difficulty of the loss that separates the two groups, it is the state of the contract. So it is not an intelligence problem, it is a source problem — and a source problem is fixed once.

The correction already under way, and what it produced

Why this figure is published rather than left aside: a rework rate reads both ways. **176 files reworked is 176 times the handler saw what the agent had not seen** — which is exactly what is being bought: a file that arrives done, and a

person who decides.
