Fictional document — demonstration example

This document is produced by the Blue Lemon Agent website to illustrate what an AI agent hands to its users. The companies, matters, amounts and people in it are invented. It has no legal, accounting or commercial value.

Fictional document, produced for the demonstration. The firm, its clients, its documents and its figures were invented; they illustrate a situation common in management consultancy and describe no real client. **The licences cited are invented for the example**; the legal principles they illustrate are real and cited.

The question is almost never “can this source technically be read”. It is “what may lawfully be loaded into holdings that 44 people query”. The two answers do not coincide, and it is the second that commits the firm.

The line that required checking, and here is its basis: loading the standards catalogue into searchable holdings would amount to extracting a substantial part of a protected database. **Article L342-1 of the French intellectual property code gives a database producer the right to prohibit the extraction of all or of a qualitatively or quantitatively substantial part of its contents** — [Légifrance, article L342-1](#), text consulted on 07/09/2026. The publisher's terms say the same, but the principle does not depend on them.

For the partners' committee to decide: the publisher sells an internal indexing licence. **184 of the catalogue entries are already covered by your application notes;** the decision therefore concerns the remainder, not the whole.

Scope of this document: the service operated by Blue Lemon Agent. For an agent deployed at your premises, the applicable location is that of the architecture set out in the quotation and verified before commissioning; local execution is announced only for the configuration explicitly described and accepted in the quotation; the applicable isolation depends on the deployment mode set out in the quotation, no dedicated isolation being presumed; the encryption mechanisms in transit and at rest, their components and key management are those documented for the architecture chosen; roles and permissions are configured and accepted for the identities and systems actually used.
