Fictional document — demonstration example

This document is produced by the Blue Lemon Agent website to illustrate what an AI agent hands to its users. The companies, matters, amounts and people in it are invented. It has no legal, accounting or commercial value.

Fictional document, produced for the demonstration. The matrix rewrites no terms: it **gathers the retailer's own** — terms of sale, 14 brand commercial warranties, 7 supplier contracts — and makes them readable reference by reference, **with the date each line was last updated**.

The three regimes, and why their overlap loses everyone

Regime	Who owes it	To whom	What it changes in the file
Statutory warranty	The seller, at no extra cost	The customer	Applies to all 4,200 references, on every channel — a contract cannot depart from it
Commercial warranty	The retailer or the manufacturer	The customer	14 different versions, 3 of which changed duration mid-year
Supplier recourse	The supplier	The retailer	The only regime that brings money in — and the one nobody was looking at

What the matrix carries for each reference

Field	Why it matters
Duration and starting point of each regime	The starting point differs: delivery, first use, or supplier invoice date
Faults covered and faults excluded	This is the line the adviser quotes to the customer, word for word
Documents required by the regime	It determines the list sent to the customer in the first message
Supplier contact and recourse deadline	A recourse identified out of time is worth nothing
Date the term was last updated	That date is what protects you the day a customer disputes

The gain: checking the cover accounted for **35 % of handling a return, it now accounts for 6 %**. An adviser no longer reads fourteen sets of terms to retain one: **they read the term used, its source and its date, in one line**. The manager's review of the matrix means **14 ten-minute readings, once**.
