The three out-of-clause increases represent €34,000 the contract does not oblige you to pay. The reply prepared for each one restates the index, the period and the applicable article of the framework contract, and offers the contractual review date as the moment to discuss it.

The price-writing mandate proposed

Element of the mandate	What it says
Purpose	Update a price in the ERP when it moves down and matches a price list signed by the supplier
Scope	The 9 referenced categories, and nothing beyond
Direction	Downwards only; an increase is presented to procurement with its clause and the comparison of alternatives
Term	Until 30/06, renewed in one word
Withdrawal	In one word, at any moment, including from a phone
Trail	Every write logged with the source list and its date of receipt

Element of the mandate	What it says
Time to execute	4 minutes after signature

The rule is asymmetric, and deliberately so: a cut applies on its own, an increase stops and comes back documented. It always plays the buyer's way.
