| <b>Trail</b>           | <b>Who settled which volume, on which scenario, at which second</b>                         |
| <b>Time to execute</b> | <b>6 minutes after signature, against a day and a half of rekeying</b>                      |

**The decision stays with sales management, and it is taken on a finished file:** cost of each level, range, effect on service level. What disappears is the day and a half of manual carry-over that used to follow the decision.
