Category	Treatment	Why
Figures with their unit	Copied	A rephrasing rounds them
Dates	Copied	"Early in the year" is not 1 January
Conditions and exceptions	Copied	They reverse what they follow
Definitions	Copied	They fix the meaning of everything else

The case that set the rule

Element	Value
Document length	40 pages
Summary length	1 page

Element	Value
Length of the vanished condition	11 words, introduced by "unless"
Effect of that condition	It reversed the clause it followed

The summary was **faithful to 39 pages out of 40, and wrong on the one that mattered.**

The statement made before writing

Example: "in one page I keep the decisions and the amounts; the justifications and the edge cases do not fit". You know what you will not be reading before you choose not to read it.

What is summarised, and what carries a caveat

Document type	Caveat at the top?
Reports, studies, notes, minutes, documentation	No
Binding document	Yes — "this does not replace reading before signing"
