Fictional document, produced for demonstration. **The first flag concerns how the agent is being used**, not the documents.

One alert only on a binding document, then silence. Chasing somebody to read a document would be badgering them, and the agent has no business measuring a person's reading.

What the summary guarantees the person who signs

What the agent guarantees	What it spares you
Figures, dates, conditions and durations are carried over identically from the document	The summary maps onto the source: no rewording can make the contract say anything other than what it says
A wrong figure in the document is flagged, never quietly repaired	You see the error and have it fixed where it lives: the summary stays enforceable against the document
Currencies and units are given exactly as the document states them	No implicit conversion slips into a negotiation: you convert at the rate and date you choose
What was left out is written into the summary	You know what you have not read, and that is the only way to use a summary without risk
A document aimed personally at its recipient is handed to them in full	The right to see it is served to the letter, and your procedure cannot be challenged on that ground
The return-to-source rate, 12%, is published as it stands, every month	You steer on a measure the agent cannot flatter: that is what makes every other figure of its own credible
