Customers who wrote in English though it was not their language	48
Most frequent reason	They assumed nobody spoke theirs

Remembering "English" for those 48 **confirms their assumption for good.**

What is done instead

Announcing the three languages served	In the first message, in all three
Detected language	Proposed, changeable in one gesture
Language set by the customer	Kept

Of the 48, **31 switched to their own language as soon as they knew it was possible**, and it took them **3.9 turns instead of 5.2**.
