The fourth "flag" is not one: it is a figure the agent publishes so that nobody asks it to bring it down.

What is upheld on every request, and what the routing gains

What is upheld	What the routing gains
A request whose category is uncertain goes to unclassified, in plain sight	8% owned and published beats a sorter that classifies everything and is wrong in silence: the 41 double hand-backs and their +11 days come from that
A request stays open until the requester has had their answer	No case drops out of chasing before anyone knows whether the reply answered
The urgency level stays the one set by whoever wrote	What is urgent for your citizen stays urgent all the way through: they know, the sorter does not
The taxonomy comes back to you costed: "Other" up from 104 to 312 in six months	You arbitrate between departments on a measurement — a category decides who works, so it is an arbitration, not a setting
An urgency goes to the competent department, and the sending department gets the real delay within the hour	The 7 urgent requests sent on a Friday evening stop waiting until Monday with nobody knowing
Times are measured per route and per cause, never per department	Nobody gains by handing a request back to protect their figures, and that is what brings the double hand-backs down
