The four items, reason by reason

Item	Original text	Proposed text	Reason retained

Item	Original text	Proposed text	Reason retained
After-sales exchange 11/06	"Grouped delivery with 14 rue Chaptal, Mrs Rivoal."	"Grouped delivery with [third-party address and customer]. "	A third party's name AND address: both are removed, either one without the other would still identify
Complaint 28/07	"The sales assistant, Aline Perrot, told me that..."	"The sales assistant, [member of staff] , told me that..."	Data relating to an employee; the substance of her answer is kept in full

What was left unredacted, and deliberately so

Element	Decision	Reason
Internal assessments of the requester's file	Kept	These are data concerning the requester himself
Grounds for refusing a goodwill gesture	Kept	The requester has the right to know what the decision was based on
Name of the store and of the department concerned	Kept	That is not third-party data, it is an organisation

Redacting more would have been more comfortable and less accurate. The right of access covers the data concerning the requester, including those that do not suit him; redaction protects third parties, it does not protect the company from what it wrote.
