This document is produced by the Blue Lemon Agent website to illustrate what an AI agent hands to its users. The companies, matters, amounts and people in it are invented. It has no legal, accounting or commercial value.

Fictional document, produced for the demonstration. **As long as the mandate is not signed, the agent hands over drafted answers; the buyer publishes them. The mandate is written, capped, dated and withdrawable with a word: that is what lets the service say yes.**

The mandate, clause by clause

Clause	Content
Scope	The 12 forms of question, listed by name — documents to provide, format and closing time, site visit, signature arrangements, division into lots, board date — and nothing else
Distribution	Every answer goes to ALL the candidates of the procurement at the same time, published on the buyer profile — a fast answer thus stays a regular one
Cap	No question touching price, the assessment of a tender or technical content — those arrive drafted within four hours, sent by the buyer
Mentions carried	The document of the file founding the answer, with its date, and the mention that it was prepared by a digital assistant of the authority
Control	A one-page daily record to the head of procurement
Term	Review at three months. Without an explicit decision at the review, the mandate stops — renewal is what requires a signature
Withdrawal	One word from the head of service, and direct sending ceases within the minute; answers return to drafts for validation
