Fictional document, produced for the demonstration. **Nothing is issued by the agent's hand**: the statements go to the head of the admissions office, discrepancies first, and she settles what goes out.

The collection chain is the circuit running from issuing the claim to its collection by the public accountant. **A file incomplete at issue is a file that will come back** — and it always comes back later than it would have cost to complete.

The 26 files flagged this week
