This document is produced by the Blue Lemon Agent website to illustrate what an AI agent hands to its users. The companies, matters, amounts and people in it are invented. It has no legal, accounting or commercial value.

Fictional document, produced for the demonstration. **This is not a blank cheque: it is a mandate bounded by twelve named subjects**, with a daily record, a review at three months and immediate withdrawal on one word.

What the mandate allows, and what it excludes

Object	Regime	What happens otherwise
The twelve subjects, named one by one	Direct answer, within two minutes	—
Any other administrative request	Reply drafted and sourced	Goes out from the admissions officer, not from the assistant
Health question	Excluded from the mandate, without exception	Referral to the care team, record handed over the same evening

Object	Regime	What happens otherwise
Information about an individual file to a third party	Excluded until the patient has designated them	Only the recorded person to notify receives what concerns them

The formal guarantees

Guarantee	Implementation
Source cited	Welcome booklet, price list or internal note, with its date
Nature of the sender	Statement that the answer was prepared by the hospital's digital assistant
Daily record	One page every morning: what went out the day before
Term	Review at three months; without an explicit decision the mandate stops — renewal is what needs a signature
Withdrawal	One word, and direct sending stops within the minute; answers go back to drafts

What the trial quarter gave

Measure	Result
Answers sent	3,100
Outside the twelve subjects	0
Information passed to an undesigned third party	0
Requests for a human officer	19, all called back the same day
Daily interruptions of the 11 officers	34 a day before, the question no longer arises

The signature stays with management — and it is taken on a text already written, in one meeting. The mandate and the information notice for the reception area are drafted; the service is live the next morning, the review is set for the 15th of the third month.
