Fictional document — demonstration example

This document is produced by the Blue Lemon Agent website to illustrate what an AI agent hands to its users. The companies, matters, amounts and people in it are invented. It has no legal, accounting or commercial value.

Fictitious document, produced for the demonstration. **Nothing goes out directly before the mandate is signed.** Until then the agent prepares draft replies; **the casework team sends them.**

What the mandate brings — the figure that decides

Clause	Content
Exact scope	The twelve subjects, named one by one, and nothing else. Any question outside the list is passed on with a draft reply — written, never sent
Absolute prohibition	No case content leaves: no reason, no amount, no income, no element of situation. On progress, three states and not one word more
Outside the mandate	The social assessment and the decision. The reply is handed over drafted, documents alongside, within 4 hours instead of 9 days — and the team sends it, which makes it reasoned and challengeable
Statements carried by every reply	The source — rules, resolution or website page — with its date, and the statement that the reply was prepared by a digital assistant of the CCAS
Next-day control	Daily record of what went out the day before, on one page — a wrong answer is caught in an hour, not in three weeks
Term	Review after three months. Without an explicit decision at the review, the mandate stops — it is renewal that requires a signature, not termination
Withdrawal	One word from the head of service, and direct sending stops within the minute; replies go back to draft for validation

The three things the agent does on its own initiative

Action	Rhythm	The reverse holds too	Withdrawal
Acknowledgement of every application	The same day	If the person asks not to be contacted on a channel, that channel is dropped within the second and letters take over	With one word

Action	Rhythm	The reverse holds too	Withdrawal
Chasing a missing document and refreshing any document more than three months old	Before the interview	A document that becomes valid again is removed from the outstanding requests at the same hour	With one word
Previous day's record to the casework team	Every morning	It goes only to the team, and it carries file numbers, never situations	With one word

A written mandate, capped, dated and withdrawable with one word is not a legal precaution: it is what makes it possible to say yes. The CCAS does not have to choose between rereading every message and signing a blank cheque.

Scope of this document: the service operated by Blue Lemon Agent.
