The rule that holds everything else together — ask rather than infer

Situation	What the agent hands over	What it gives
A document is missing from the file	What is missing, where it looked, who holds it — and the request already drafted	A guessed value would be indistinguishable from a read one
Income cannot be found	The absence flagged and the request ready to go	That is what makes 2.1 % a figure you can rely on

An unconfirmed flag never costs anyone an entitlement: it costs an interview, which is why it gets corrected. **An entitlement never flagged, on the other hand, shows up nowhere — and that is the one that costs.**
