Fictional document, produced for the demonstration. **The calculation belongs to the post and runs to three lines** — it can be redone without us, from the consulate's own logs. **This is the page to hand the head of post the day before the meeting.**

The calculation, item by item

The conversion uses the statutory basis of 35 hours a week, and the rounding is downward: forty-three weeks amount to 1,505 hours, the post returned 1,526. **These hours are not a staffing saving and must not be presented as one:** no post was cut, none was created. **It is public money spent on what the officials alone know how to do.**
