This document is produced by the Blue Lemon Agent website to illustrate what an AI agent hands to its users. The companies, matters, amounts and people in it are invented. It has no legal, accounting or commercial value.

Fictional document, produced for the demonstration. **A general document list makes people come back; a list drawn up for their situation makes them come once. For a national living nine hundred kilometres away, that is the whole difference between a procedure and a journey.**

What the agent does before the person sets off
