The conversion basis is single and it is stated: *a 35-hour week, a working year of 1,607 hours, a month of 151.67 hours, always rounded down. 1,272 hours is more than thirty-six weeks, that is more than eight months — and the figure in hours stays the reference: the conversion illustrates it, it does not replace it.*

These hours are not a saving on posts, and they must not be presented as one: no post was cut, none was created. **It is officer time given back to the service** — redeployed onto special procedures, files with no precedent and support to companies that have no customs department.
