Fictional document — demonstration example

This document is produced by the Blue Lemon Agent website to illustrate what an AI agent hands to its users. The companies, matters, amounts and people in it are invented. It has no legal, accounting or commercial value.

Fictional document, produced for the demonstration. **Nothing goes out directly before the mandate is signed.** Until it is signed, the agent prepares draft answers; **a public officer sends them.**

What the mandate brings in — the figure that decides

The mandate, in six lines

Clause	Content
Exact scope	The fourteen subjects, listed by name, and nothing else. Any question outside the list is handed over with a draft answer — written, sourced, never sent
Outside the mandate as a matter of principle	No answer on an individual file in progress: a declaration being processed, an authorisation application under examination, a file followed by an officer. The answer is handed over drafted within 4 hours, and it goes out from a public officer
Statements carried on every answer	The source — office sheet or designated official source — with its date, and a statement that the answer was prepared by a digital assistant of the office
Next-day control	Daily record of the answers sent the day before, on one page — a wrong answer is caught in an hour, not in three weeks
Term	Review after three months. Without an explicit decision at the review, the mandate ends — renewal is what requires a signature, not stopping
Withdrawal	One word from the unit head and direct sending stops within the minute; answers go back to being drafts to approve

A written mandate, capped, dated and withdrawable with one word is not a legal precaution: it is what makes it possible to say yes. The service does not have to choose between reading every answer and signing a blank cheque.
