Fictional document — demonstration example

This document is produced by the Blue Lemon Agent website to illustrate what an AI agent hands to its users. The companies, matters, amounts and people in it are invented. It has no legal, accounting or commercial value.

Fictional document, produced for the demonstration. **The declarant's credentials are never entrusted to the agent and do not need to be: the declarant enters and validates, and it is that act which makes the declaration his, therefore valid.**

What the agent does, and in what order

Step	What the agent brings	Why it comes here
Before the screen	The list of documents to prepare, with what each must show	This is the most common drop-out: the declarant starts, a document is missing, he closes
During entry	Reading the screen: what is asked, why, what the service will do with it	A question read out loud is the question answered correctly

Step	What the agent brings	Why it comes here
Before validation	The check for inconsistencies: a quantity not matching the invoice, a missing currency, a document announced but not uploaded	An inconsistency fixed before filing is a request for a supporting document that never exists
Validation	It is done by the declarant, with his own credentials	That is what makes the declaration binding on him and on nobody else

What that gave over the quarter

Measure	Value	Reading
Guided sessions	512	—
of which carried to the end	468	The other 44 were waiting for a document to be obtained elsewhere, and each left with the request already drafted
Declarations filed incomplete	One in five → one in fourteen	96 requests for supporting documents the office did not have to write
Tuesday late-afternoon desk	61 declarants received	38 of them from small companies with no customs department — those who never call during office hours

An incomplete filing costs twice: a request for a supporting document for the office to write, and days of waiting for the company whose goods are not moving. **Removing it at the entry stage removes both at once.**

The desk is run by the agent, with an officer of the unit reachable for anything outside the fourteen subjects. **It adds no opening hours to fund and takes none away from traders.**
