Fictional document — demonstration example

This document is produced by the Blue Lemon Agent website to illustrate what an AI agent hands to its users. The companies, matters, amounts and people in it are invented. It has no legal, accounting or commercial value.

Fictional document, produced for the demonstration. **The names of people are invented. The letters are written, not sent: the signature of the head of the residence office remains the act that sends them.**

The proposed sending order, and what it unblocks

Why not send them all on the same day: 3,100 letters at once produce roughly 1,800 returns in the same three-week window, that is **1,800 documents to read, check and file for sixteen case officers**. Spreading them delays nothing — **all 3,100 letters are written today** — it avoids a jam that would cost more than the wait it removes. **The waves are sized on the observed 58 %, not on the projected rate of the new templates: if those hold their 74 %, the return load will be heavier, and it is the spreading that absorbs it.**

Your application to renew your residence permit bearing the « student » endorsement, filed on **18 August 2026** under number **2026-04871**, is duly registered by my services.
One document is missing for its assessment to continue.

Document required: proof of your resources for the **last three months** — bank statements, grant certificate, or a sponsorship undertaking accompanied by the sponsor's proof of resources.

Why: line 7 of the list of documents annexed to the service note of 12 January 2026 requires it for the renewal of a permit bearing this endorsement. **Your file holds two statements out of the three expected, and no sponsorship undertaking.**

Filing deadline: 28 September 2026.

What submitting this document does not change: your application remains

registered at its original filing date. **Completing your file does not send it back to square one.**

Three ways to submit it: through the online service, section « complete my file », with your file number · at the desk, by appointment booked online · by post to the address above, quoting your file number.

If you have difficulty obtaining this document, write to us: a case officer will tell you what to do.

For the prefect and by delegation, the head of the foreign nationals' residence office

What this letter does and the previous one did not: it **names the exact document and the period covered**, it **cites the line that requires it**, it **says precisely what is missing from the file** instead of inviting the applicant to « complete » it, it **reassures on the filing date** — the applicant's number one fear —, and it **gives three ways to submit, two of them without travelling**. **Across the 1,040 files under template A, the projected return rate rises from 58 % to 74 %.**

What follows on, with no new campaign

Every night, the files filed or amended the day before are checked, and the missing-document letter is written within twelve hours of filing. At the observed rate of **12,000 filings a year**, that is **about 60 letters a week**, each attached to one of the five approved templates. **No file will sit incomplete for three months without anyone noticing: it will be known the next day, and so will the applicant — which is the first protection against an implied refusal arising from an oversight.**

Scope of this document: the service operated by Blue Lemon Agent.
