Fictional document — demonstration example

This document is produced by the Blue Lemon Agent website to illustrate what an AI agent hands to its users. The companies, matters, amounts and people in it are invented. It has no legal, accounting or commercial value.

Fictional document, produced for demonstration. No real holding or tag numbers.

No notification is sent from this page: a notification binds the keeper and carries their number.

None of the three has a receipt on file — which is not the same as a breach.

If one of them was declared from the portal and the receipt was never filed, it is in order: say so and it leaves this list. **For those still to be notified, notifying today does not erase the delay: it stops the clock.** That fact is written here rather than omitted, because an inspection will see it anyway.

These two fields are not pre-filled. The origin could be guessed from your correspondence this month — and a guessed origin, entered on a notification that stands as proof, would be a false declaration dressed up as a convenience.

Who holds the document

The accompanying document is issued by the previous keeper and handed to the haulier. If it has not arrived, it is either with the seller or with the haulier. Both numbers appear in your correspondence of 21/07.

Closing them without notifying anything

Your answer	What happens	What stays between you and the agent

The agent does not query the identification body to find out whether you declared. That would be technically appealing and practically questionable: a farm has no reason to have its record queried by a tool, and the shortest answer remains yours.
