Fictional document, produced for the demonstration. **Established by comparing two populations within the same inbox — fast replies and late replies — not by opinion.**

All three deadlines missed in the previous half-year belong to the « more than 4 days » population. None of the three messages carried a word of urgency in its subject line: the clause that made them critical lived in the contract, not in the message.
