What the mandate contains, line by line

Mandate clause	Value retained
Scope	The three families above, by name
Cap	25 messages a day — at the 26 th , stop and a message to the director
Duration	3 months , renewal written, never tacit
Log	Timestamp, recipient, family, full text — readable at any time
Periodic extract	Included in Monday's briefing
Automatic exit	An amount, a contractual date or a person's name sends the message back to drafts
Withdrawal	One word — « stop mandate » — immediate effect, nothing lost

What stays under signature, and what it really costs

Price, discount, commercial term	61	1
Contractual deadline or date commitment	118	2
Decision touching a person	44	< 1
First exchange with an unknown correspondent	171	3
Total	394	Fewer than 5 a working day

A mandate is only useful if it is narrow. Widened to « anything routine », it becomes unverifiable: hence the named scope and the automatic exit.
