The two routes, depending on what turns up

If	Then	Timing
The amendment was indeed voted in 2022	An amending declaration is filed; the September meeting is held under the voted rules once declared	Tight, but before 26/09
Nothing evidences a vote	The meeting is held under the 2019 version, and may resolve to amend the constitution then	No prior formality

The second route is simpler and less comfortable: it means convening under a one-third quorum, when recent practice has used one quarter. Which is exactly why it is better known now than a quarter of an hour before the doors open.
