This document is produced by the Blue Lemon Agent website to illustrate what an AI agent hands to its users. The companies, matters, amounts and people in it are invented. It has no legal, accounting or commercial value.

Fictional document, produced for the demonstration. **The 3 updated versions are written**, each aligned with the decision in force, **with the replaced line and the line that replaces it side by side**. **The head of service reads them, corrects with a word and settles the version — and it is that approval which makes the sheet stand up before a resident who challenges it.**

The 3 sheets older than the decision that amends them

These 3 discrepancies existed before the agent. They only show when the sheet and the decision that amends it are placed side by side — **and nobody had the time to do it, because that work only shows when it has not been done. Matching the 62 sheets now takes one night, and it starts again every night.**

What each rewritten version carries

The three topics to open first, and why those

Opening all fifteen topics at once would take 100 minutes of reading and push the go-live back three weeks. **Three topics, twenty minutes, 43 % of the flow: it is the best ratio available**, and the other twelve follow at four a week — **the whole set is live within a month, and the first gain lands the next day.**

The action that stops it happening again

When	What the agent does	What comes back to the town
Every night	It matches the 62 sheets against the published decisions and rewrites any sheet a decision amends	Five minutes of approval per decision
At the same hour	A sheet the town takes off the website leaves its answers	Nothing — withdrawal is enough
On request	It quantifies what the updated version would have changed over the past twelve months, answer by answer	Go-live, approved with a word

It is this action that took substantive corrections from 3.4 % to 0.6 % from one quarter to the next. The 62 sheets stop ageing in silence, and the read-through will never again have to be done in one block.

For the town to settle

Order of revision of the 3 sheets approved by the head of front-desk services: _____

Scope of this document: the service operated by Blue Lemon Agent.
