The seventh point is the one that gets forgotten. A provision made in 2023 for a dispute settled since March: it was seen because the settlement agreement is on file, not because an account moved.

The three points depending on a third party

Point	What is awaited	From whom
2	Justification of the credit balances	Two suppliers
5	Copies of two invoices	Two customers
6	A position on a filing treatment	The accountant

Those three should be started first, whatever their weight in hours: they are the only ones whose clock runs outside the company.

The order proposed

4	Points 3, 4 and 7	Quick, an accounting decision
