Fictional document — demonstration example

This document is produced by the Blue Lemon Agent website to illustrate what an AI agent hands to its users. The companies, matters, amounts and people in it are invented. It has no legal, accounting or commercial value.

Fictional document, produced for the demonstration. **The payment order is suspended, not sent:** a missing document means a rejection by the public accountant a fortnight later, **and the payment-period clock keeps running all that time.**

What the request carries — and why it comes back quickly

Item	Content	Measured effect
Payment order number, supplier, amount	Taken from the software	The spending department identifies the file without searching
The exact document that is missing	Certificate of certified service, signed delivery note, acceptance report	A precise request comes back in 3 days; a generic one in 11

Item	Content	Measured effect
The officer in the spending department who committed the expense	Taken from the commitment	The request reaches the right person first time
Date the invoice arrived	Platform timestamp	Makes visible the time already used on the payment period

Suspending rather than sending — the arithmetic

Route	Cost in days	Consequence
Suspend and request the document	3 days on average	The payment order goes out complete
Send without the document	15 days	Rejection by the assigned public accountant, then the whole circuit starts again

What it gave over the quarter

Measure	This quarter	Same quarter last year
Document requests prepared	740	A quarter of the year's 2,960
Returned within eight days	681	—
Rejections by the assigned public accountant for a missing document, on the checked batches	0	96
Documents outstanding for more than a fortnight, on the 6 trial departments	12	88

What stays with the department, and comes back to it ready: assessing regularity and issuing the payment order belong to the authorising officer, payment to the public

accountant — **and the file reaches them complete, documents alongside and a reasoned control note, within a delay counted in minutes. What disappears is the search for the document and the typing of the letter.**

The weekly statement to spending departments

Content	Frequency	Effect observed on the 6 trial departments
List of documents awaited, with the age of each	Every Monday	Documents outstanding for more than 15 days: 88 → 12 in a month
