Settling a diagnosis	Elements gathered, sourced, ordered	An analysis owned, dated and discussable with the person
Directing	Applicable schemes, conditions ticked	Same
Referring to training	Places, lead times, funding checked	Same
Awarding a grant	Conditions ticked, documents checked, amount calculated	Same

A decision with effects on a person never rests on automated processing alone. It is taken by the adviser — and guidance nobody had signed could be argued with by nobody, whereas a jobseeker is entitled to argue with what they are offered.
