A real question, and its answer

“Which grant for a jobseeker over 50, without a driving licence, who lands a job offer 28 km away?” — answer in twenty seconds: two schemes that can be combined, a third excluded by a service note from last spring, the current form, the partner who processes it and the observed lead time — 11 days.

What that weighs

The collection is reread whenever a service note is issued, and the updated version is written overnight. A jobseeker stops hearing two different answers depending on which adviser is opposite — **that is equal treatment, not documentary comfort.**
