4	Write down the tracking number that appears	Keep it safe	1 minute

One user in two already holds a national digital identity without knowing it — through tax, through health insurance. **Checking that first saves creating one more account and one more password.**

The papers to get ready

Paper	What it is really called	Checked today?
Your current vehicle document	Vehicle registration document	Yes — shown at the desk
A paper proving where you live	Proof of address less than six months old	Yes — four months old, it is valid
Your identity document	National identity card or passport	Yes

The three traps in this procedure

Trap	What happens	How to avoid it
Proof of address more than six months old	The application is rejected after several weeks	Checked at the desk before filing
Missing transfer code	Blocks the procedure if the vehicle was just bought	Ask the seller before starting
Used name different from civil status	The application matches no record	Enter the name exactly as on the identity document

Who does what

Role	What they do	What it guarantees you
You, the user	You validate your application from your own account	The procedure is yours: enforceable, and open to challenge if the answer is slow
The adviser	Guides you, checks your papers, reviews the summary	A service decision, reasoned and logged
The AI agent	Prepares the path, gathers and checks the documents, pre-fills the form, flags the traps, prints this document and tracks the case	It is all done before you sit down: 43 minutes become 7
