Fictional document — demonstration example

This document is produced by the Blue Lemon Agent website to illustrate what an AI agent hands to its users. The companies, matters, amounts and people in it are invented. It has no legal, accounting or commercial value.

Fictional document, produced for the demonstration. **The only honest measure of how readable a letter is is not what we think we wrote: it is what people call us back to ask.** The five wordings below were identified by matching outgoing letters against the calls received within fifteen days.

The five wordings, and what they cost

Wording	Calls per year	What the member understands
« Periods not validated to date »	1,340	That something is required of them, without knowing what
« It is for you to provide »	1,020	That a document is missing, without knowing which or where to get it

Wording	Calls per year	What the member understands
« Your file is undergoing further examination »	780	That something is wrong
« Subject to the information in our possession »	610	That the amount stated may not be the right one
« Where applicable »	350	Nothing — it means nothing to the reader and protects nothing for the writer
Total	4,100	Out of 41,000 calls received in the year

The rewrites, with legal reach unchanged

Before	After	What removes the call
« Periods not validated to date »	« Three periods are not yet validated: 1999, 2000 and 2001. We wrote to the scheme concerned on 14 March and we will chase on 14 April. There is nothing for you to do. »	The last sentence
« It is for you to provide »	« One document is missing: your record of military service. You obtain it here, and this is how. »	The exact name of the document and the route to obtain it
« Where applicable »	Deleted	The absence of an empty phrase

What is never rewritten: the mandatory statements, the appeal channels and time limits, and the wordings the regulatory specialists have settled. **The agent rewrites what informs, never what binds** — and the 14 templates were reviewed by the two specialists before go-live.

The measured result over the trial quarter
