What the mandate covers, and what it does not

Object	Regime	Who decides
The 6 settled indicators — execution by chapter, execution by service, commitments, carry-overs, budgeted headcount, live contracts	Circulated directly to the directorates, each with its written definition and its extraction date	Regime signed by the finance director

Object	Regime	Who decides
Projections and analytical comments	Outside the mandate — a projection commits an assumption	Handed over drafted within 2 hours instead of 4 days, and it is the director who circulates them
Personal data	No circulation, whatever the request	The aggregate answering the same question is supplied as a matter of course

What the mandate brings, measured over the trial

Measure	Before	Under the mandate
Execution position obtained by a directorate	4 days	40 seconds
Budget overruns avoided	—	3 over the quarter, because the directorate saw them coming
Analytical notes circulated	4 days	2 hours

The safeguards, written into the mandate itself

Clause	Content
Traceability	Every figure carries its source, its extraction date and the statement that it comes from a digital assistant of the finance department
Daily summary	One page every morning: what went out the day before — a wrong figure is caught in an hour, not at the next committee

Clause	Content
Duration	Review after three months, with the record to hand. Without an explicit decision, the mandate stops — it is renewal that requires a signature, not termination
Withdrawal	One word, effective within the minute: the indicators return to approved circulation, nothing else changes
Information of the directorates	Note to the 9 directorates, published with the signed regime

A written definition is worth more than a right figure: each of the six indicators carries its definition and its extraction date, which removes half the committee discussion — the half that was about what the figure measured.
