This document is produced by the Blue Lemon Agent website to illustrate what an AI agent hands to its users. The companies, matters, amounts and people in it are invented. It has no legal, accounting or commercial value.

Fictional document as to the file and the volumes, produced for the demonstration. **The method, however, is the one being sold:** no line without its official address, its update date and its conditions to check — and no line tells a founder they are entitled.

The shape of a checklist line

Column	Content	Why it exists
Scheme	Its official name	Avoid blog-post labels
Source	The address of the official page	Let the founder check
Update date	The one shown by the page, not the reading date	Make the hand-over stand up
Conditions to check	Reproduced as the page states them	Never summarise a condition

Regional and local schemes are the ones that move most and the ones internal documents date least. That is where the « update date » column earns its keep: it turns a list into evidence.

What the checklist allows on the day of a dispute

Item produced	What it establishes
The exact version handed over on 14 March	What was told to the founder that day
The update dates of the official pages as of that day	That the information was the one in force
The name of the adviser who approved it	Who committed the organisation
