A document that is present but expired blocks the filing exactly like a missing one. That is why the check is on content — expiry date, signature, matching names — and never on the mere presence of a file.

The chaser, exactly as it went out

« Hello Léa,

One document is missing from your file: the certificate of filiation. A birth certificate less than three months old, or the corresponding page of your family record book, will do.

Until it is attached, filing on the single window stays blocked — it is the only thing holding your file up today.

Your adviser remains your contact for any question of substance. »
