Fictional document — demonstration example

This document is produced by the Blue Lemon Agent website to illustrate what an AI agent hands to its users. The companies, matters, amounts and people in it are invented. It has no legal, accounting or commercial value.

Fictional document, produced for the demonstration. **An image release is the agreement signed by the person photographed**: it is bounded by supports, a territory and a duration — often shorter than the photographer's assignment. **A font licence is the contract permitting the use of a typeface**, almost always limited by workstations or by page views.

Retail brand typeface	Desktop, 5 seats	5 studio seats + 2 partner agencies	Extension to 12 seats — price supplied. The only genuine gap in the estate.
Web display typeface	250,000 page views/month	310,000 since the spring campaign	500,000 tier, to be taken before peak season, not during
Text typeface	Unlimited, perpetual purchase	Compliant	No action
Partner brand typefaces	Supplied by the partner	Compliant with the co-branding contract	Register kept, expiry tracked

The time the register replaces

Before	After

Half a day of checking per campaign, under pressure and never complete	Register kept continuously; an alert arrives with its solution, not with a problem
Expiry discovered after publication	Alert 90 days ahead, letter or amendment already drafted
No overview of typefaces	Full estate, with the next tier and its foreseeable crossing date
