What the criterion says

"Flag files whose applicant's surname is identical to that of an applicant on a live file."

A shared surname is not an indication. In a medium-sized authority it is common — and more common for some names than others, which makes the criterion unequal in its effects before it is even ineffective.

Two of the three confirmed share a characteristic the criterion does not test.

In other words, a criterion combining surname, address and bank details would have caught two of the three while producing far fewer flags — but it is for the service to write it and test it.
