What is checked, document by document

Document	What is checked	Most frequent discrepancy
Registration extract	Issue date, match of name and identification number with the form, declared activity against the eligible activities	Declared activity different from the project's actual activity
Accounts	Financial year covered, closing date, presence of both required years	34 of 180 applications contained only one year — the gap was only spotted in committee

Document	What is checked	Most frequent discrepancy
Tax and social security certificates	Validity date compared with the likely committee date	Valid at filing, expired at the vote — the application is deferred
Quotations and agreements	Date, subject, consistency of the amount with the declared eligible cost	Quotation too old to support the eligible cost

The registration extract is the document establishing the company's legal existence, carrying its name, its identification number and its declared activity. These four checks are precisely the ones nobody has time to run at six in the evening before a committee.

The result measured over the year

Applications sent back for documents	38%	12%
Cost of a return to the business	19 days on average	—

A business does not separate the assessment time from the time taken by its own missing document: it remembers that the authority took three months. **Cutting document returns cuts the perceived delay — and the perceived delay is the one that gets told to the neighbour.**
