Fictional document — the decree, the order and the court decision below are **invented for the demonstration** and reproduce the fiche's own example; in service, the agent cites the real official sources with a link to each. **Nothing is circulated:** the bulletin awaits the signature of the head of the documentation service, and can be taken back with a word until it has gone.

The sift published — the 172 publications set aside and their reason

The sift is published, and it can be challenged. Each of the 172 set aside can be pulled back with a word, with its reason and its date. It is this record that improved the monitoring: in the first quarter, **out of 2,150 publications reviewed, 3 had been set aside wrongly — all three on the water and wastewater topic, whose vocabulary was too narrow. 41 terms were added to that topic. In the second quarter, out of 2,150 publications: 0 discards of that kind, and 11 additional publications retained, 2 of them with an impact. This record is published every quarter, unasked: monitoring whose misses are not measured is monitoring you know nothing about.**
