Fictional document, produced for the demonstration. **A member who does not understand how an amount was reached does not challenge it: he telephones** — and he telephones fourteen people already at peak.

These are not lost complaints: they are members who understood first time. A complaint fewer about not understanding is a complaint that had no reason to exist.

Any template amended by a new instruction is flagged and rewritten within the 24 hours following its circulation. Templates stop ageing in silence, and this work does not have to be redone in two years.
