The three automatic acts

Flagging and rewriting a scale or required document amended by a board decision	The day after the meeting	It is the act that took substantive corrections from 7.4 % to 1.1 %
Weekly record to the head of department	Every Monday	The only unprompted send, and it goes to her alone

The four decisions that stay with a person

Decision	What the agent prepares	What the signature brings
Opening an entitlement	Conditions ticked, scale applied, reasoning written	A decision reasoned, dated, traced and open to challenge
Revising an entitlement	Breakdown of the change, dated effect	Same
Suspending an entitlement	Triggering event, documents alongside	Same
Recovering an overpayment	Month-by-month breakdown, share not attributable to the claimant flagged	Same

A decision with effects on a claimant never rests on automated processing alone. It is taken by a caseworker — and **a decision nobody had signed could be challenged by nobody, so it would be worth nothing to a claimant.**
