Fictional document — demonstration example

This document is produced by the Blue Lemon Agent website to illustrate what an AI agent hands to its users. The companies, matters, amounts and people in it are invented. It has no legal, accounting or commercial value.

Fictional document, produced for the demonstration. **Nothing goes out directly before the mandate is signed.** Until then the agent prepares draft answers; **it is the officers who send them.**

What the mandate earns — the figure that decides

The mandate, in six lines

Clause	Content
Exact scope	The 16 topics, listed by name, and only in their general dimension: what the text says, what the procedure is, what the deadline is, which documents to provide
Absolute prohibition	No answer that would amount to a decision on an individual situation: refusal of part-time, recognition of length of service, pay adjustment, entry into pay. The file is handed over processed to the officer, and the authority signs
Wording carried by every answer	The source — statutory text, resolution, internal memo or notified decision — with its date and its extract, and the digital assistant announcement from the first sentence
Next-day control	Daily record of the answers that went out the day before, on one page — an inaccurate answer is caught the same day
Term	Reviewed after three months. Without an explicit decision at the review, the mandate stops — it is renewal that takes a signature, not termination
Withdrawal	One word from the department, and direct answering stops within the minute; answers revert to drafts for approval
