Fictional document — demonstration example

This document is produced by the Blue Lemon Agent website to illustrate what an AI agent hands to its users. The companies, matters, amounts and people in it are invented. It has no legal, accounting or commercial value.

Fictional document, produced for the demonstration. **Three automatic actions, not one more, each withdrawable with a word** — and a reversibility that is checked before signing a second year, not after.

The three automatic actions

Action	What it does	Its reversibility
Matching before each run	Holds the reminder back when the instalment is settled	A wrong hold surfaces in the Monday check — 6 cases over 12 months, caught within 8 days
Acknowledgement within the hour	What the document is, what it settles, what is missing	Grants nothing and commits nothing — “did you receive it?” chasers: 340 → 41 a month

Action	What it does	Its reversibility
Monday record to the service	Holds, documents outstanding, requests falling due, missed instalments	The only unprompted dispatch, and it goes only to the service

The four signatures that stay with an officer

Act	What the signature brings
Granting time to pay	A reasoned, dated decision, enforceable
Granting a waiver	A collective decision, comparable to the earlier ones
Starting enforced collection	The service's heaviest act stays the most human
Any adverse decision	Challengeable — therefore the contributor has been heard
Over two quarters	8,000 outputs, 8,000 approvals by a person

The exit, point by point

Element	What becomes of it	Whose it is
The index	Deleted — it held no entries, only what is needed to find them	—
9 years of accounts and correspondence	Have not moved a byte — same software, same permissions	The body
14 answers, updated templates, matching rule, waiver grid	Stay in the body's files, readable without us	The body

Element	What becomes of it	Whose it is
Production log	Handed over in an open format, or destroyed	The choice is settled at go-live, not on departure

No migration on the way in, therefore none on the way out. The management software is not replaced, no format belongs to us, and no officer has changed how they work other than reading instead of writing.

The dry-run exit

Parameter	Value proposed
Timing	End of the first quarter
Duration	Half a day: switch off, check, switch back on
Least costly date	The third Wednesday of the month — the quietest day between two due dates, on your own records
Protocol	Written, one page

Management will know what the promise is worth before committing a second year. It is the only way to check a reversibility: to do it.
