What each line carries

Column	Content	Why it is there
Sequence number	Order of receipt at the registry	A reference citable in any document
Nature of the document	As the establishment's filing plan names it	One nomenclature, whichever court sent it
Origin	Issuing court or service	Knowing who to ask again
Date of issue	Shown on the document	Consistency check

Date of receipt	Recording at the registry	Consistency check
Officer who recorded it	By name	Chain of the register

The three checks run at generation

What it changed on missing documents
